BACKGROUND

Israel Policy Forum is an educational and policy organization working to shape the discourse and mobilize support among American Jewish leaders and U.S. policymakers for the realization of a viable two-state solution consistent with Israel's security. We do this by educating political and communal leaders on pragmatic policy ideas to improve Israel's security while maintaining conditions for two states, and by building consensus in the policy and Jewish communities for these visions and goals. We envision a Jewish, democratic, and secure Israel, and support a strong and enduring U.S.-Israel relationship.

POSITION SUMMARY

Israel Policy Forum has an exciting opportunity for an IPF Atid National Organizing Fellow. Created in July 2017, IPF Atid engages thousands of young professionals in their 20s and 30s, both online and in person. IPF Atid has active chapters in Chicago, Boston, Los Angeles, New York, San Francisco, and Washington, D.C., a yearlong fellowship and annual summit for young leaders across North America, a summer delegation to Israel and the West Bank, and a variety of virtual and in-person programs throughout the year

Working closely with the IPF Atid staff, this full-time fellowship spanning Summer 2022 to Summer 2023 will focus on engaging leaders of Israel Policy Forum's young professionals program and the wider community. This position, ideal for recent college graduates and early-career professionals, will support and develop creative, inclusive, and impactful programs and initiatives for IPF Atid communities.

The National Organizing Fellow will be involved in advancing many aspects of IPF Atid's work, including educational programs that promote and animate IPF's mission, policy objectives, and core content, as well as building and strengthening relationships with members of the IPF Atid network.

PRIMARY RESPONSIBILITIES

- Provide logistics and strategy support for IPF Atid's Bronfman Conveners Summit (Fall 2022) and subsequent cohort programming in the year following summit
- Engage with IPF leaders to develop projects in their local communities, including dialogues, policy briefings, Shabbat dinners, social gatherings, and more
- Manage day-to-day communications to the IPF Atid Leadership Network and broader community via email,
 Facebook, and WhatsApp
- Continually seek ways to strengthen the cohesion of the IPF Atid community and proactively identify opportunities for community growth and expansion
- Opportunities to write op-eds and conduct research to support the policy and communications team

 Work collaboratively with other departments at Israel Policy Forum, especially the communications and Jewish communal partnerships teams, to ensure holistic, integrated programmatic and communications outputs
